In exercise of the powers under sub-section (1) of section 3 of the Uttar Pradesh State Capital Region and other Regions Development Authority Act, 2024 (U.P. Act no. 6 of 2024) , the Governor, is pleased to declare that the area comprising Varanasi and its surrounding areas as mentioned in the Schedule below shall be called the "Kashi-Vindhya Region" .
